Candidate's Statement: I have a natural affinity for the Professional Relations Division of the ACS. I am a charter member, as well as one of the councilors who signed the original petition to establish it. As the chair of the Economic Affairs Committee (a predecessor of CEPA). I instituted the first salary survey of chemists and the first investigation of industry layoffs. But enough of history! - what should occupy us is today and tomorrow.

PROF stands in unique contrast to the more traditional efforts of the ACS. While much of what ACS does( and has done) has focused on advancing the chemical sciences and the education of chemistry associated scientists, only PROF has been concerned with the well-being of ACS members with respect to their professional status. Much of what the ACS presently does to promote professionalism comes from initiatives first proposed by PROF.

In the past two decades we have seen many jobs exported overseas, but have comforted ourselves with the theory that knowledge-based workers, particularly professionals in the hard sciences (chemistry, physics, etc.) were protected from this sort of exportation. Unfortunately, this is no longer the case. We are now seeing that some of the multi-nationals are starting to also export these job-types. What can be done about this? I believe this offers the ACS a unique opportunity to intercede, if we go about it with the

right approach.

Given the current economic depression, it appears that the government, after many years, is beginning to recognize that one of the drivers of economic recovery is scientific innovation and is contemplating greatly increasing support for scientific research and discovery. The ACS should quickly involve itself in supporting and encouraging these initiatives. In addition, many of these multi-nationals avail themselves of the research tax deductions given for research. PROF should advocate that the ACS take the position that these research tax benefits only be extended to those funds expended in the United States to support the sciences nationally-- funds expended overseas would not be eligible for these tax benefits. This would be a powerful incentive to keep and create jobs in the US. for chemical scientists. This would also have the collateral effect of supporting chemical science education in the US.

If elected chair of PROF, it would be my intent to promote initiatives such as I have described above in order to advance the welfare of our national membership. If this makes sense to you, I ask for your vote. Thank you!
